

November 4, 2014 Special and State Election

The Electors of the Town of Mansfield are hereby warned to meet at their respective polling places in said town on Tuesday, November 4, 2014, for the following purposes:

- I. To cast their votes for Governor and Lieutenant Governor, Representative in Congress, State Senator, State Representative, Secretary of the State, Treasurer, Comptroller, Attorney General, Judge of Probate, Registrar of Voters.
- II. To cast their votes for Judge of Probate to Fill Vacancy for the Tolland-Mansfield Probate District.
- III. To vote on the following question for the approval or disapproval of a proposed AMENDMENT to the Constitution of Connecticut, a vote of "Yes" being a vote for approval, and a vote of "No" being a vote for disapproval:
 1. "SHALL THE CONSTITUTION OF THE STATE BE AMENDED TO REMOVE RESTRICTIONS CONCERNING ABSENTEE BALLOTS AND TO PERMIT A PERSON TO VOTE WITHOUT APPEARING AT THE POLLING PLACE ON THE DAY OF THE ELECTION? "

The full text of such proposed question with explanatory text, printed in accordance with §2-30a of the General Statutes, is available at the Town Clerk's office for public distribution.

The vote on the proposed question is taken pursuant to the Constitution of Connecticut.

- IV. To vote on the following local question for approval or disapproval of a resolution approved by the Town Council on September 2, 2014, which question will be placed on the voting machines under the following heading:
 2. "SHALL THE TOWN OF MANSFIELD APPROPRIATE \$9,000,000 FOR THE FOUR CORNERS SANITARY SEWER PROJECT, AND AUTHORIZE THE ISSUE OF BONDS, NOTES AND OTHER OBLIGATIONS TO FINANCE THE PORTION OF THE APPROPRIATION NOT DEFRAID FROM GRANTS (ESTIMATED NET PROJECT COST OF \$6,000,000)?"

The vote on the above question will be taken under the authority of Sections 406 and 407 of the Town Charter and Sections 7-7, 9-369 and 9-369d of the Connecticut General Statutes. A vote of "YES" will be a vote for approval of the resolution, and a vote of "NO" will be a vote for disapproval of said resolution. The full text of the resolutions is on file and open to public inspection in the office of the Town Clerk. Application for absentee ballots should be made to the Town Clerk's office. Electors shall vote on the question at their respective polling places. Persons qualified to vote in town meetings who are not electors will vote at the following polling place: Registrar of Voters Office, Audrey P. Beck Building, 4 South Eagleville Road in Storrs, Connecticut.

Notice is hereby given that the location of the polling places is as follows:

Voting tabulators will be used. The polls will be opened at six o'clock in the morning (6:00 a.m.) and will remain open until eight o'clock in the evening (8:00 p.m.).
